Arrival at Game Site

Officials should arrive at least 45 minutes prior to scheduled kickoff

Match Duration

- 45 minute halves
- 10 minute maximum half-time
- Added time at referee discretion

*Note: There may be a school affiliated administrator on site who may be doing a "check-in". Officials are still required to perform check-in procedures.





Game Balls

- Home team is to provide a minimum of 3 game balls
- One home ball behind each goal for use in the game
- Balls should be inflated to 13PSI, or as required by the manufacturer

Check In Procedures

- 30 minutes to Kick-Off
- Valid School ID
- Name must be **printed** on roster (no write-ins)
- Failure to have both a school ID and be listed on the match report will result in the player being ineligible to play
- Can verify rostered player by checking the team page on our website

Substitution

- Unlimited Substitution
- Any Stoppage

Technical/Bench Area

- Spectators must sit opposite sideline of the teams.
- If games are played in a stadium, no spectators are allowed at field level.
- Only coaches, players, and school administrators are allowed in the technical/bench area

<u>Uniforms</u>

- All uniforms must have a unique number
 - Each player is to have a corresponding number on their roster





- Taped jersey numbers are not allowed
- If team only has 9 jerseys with unique #'s, only 9 players will be able to play

Spectator Behavior

 Spectators are expected to behave according to the their academic institutions policy. If the referee is informed of or witnesses such inappropriate behavior, they are to contact the site/academic administrator and inform them that such behavior must be stopped. If no school administrator is available, discuss the situation with the coach and remind him of his responsibilities for managing the situation. If the behavior continues, the Referee should suspend the match –up to 5 minutes-until such person(s) is removed from the facility. If the situation is not remedied within 5 minutes, abandon match.

Recording & Reporting Match Information

After the game, log into game officials and identify that you're reporting. Click on the green "WCSA Game Report" and proceed to complete the report.
